APPENDIX B

HAZARDOUS MATERIALS REMOVAL WORKER

RELATED INSTRUCTION

Safety

- OSHA 10-Hour Construction Course – if required for Public Work
- Precautions in working at a construction site, with heavy equipment and moving vehicles
- Use of personal safety clothing, respirators and other devices
- Fall prevention
- Confined space safety
- Asbestos safety
 - Successfully complete a course approved by the New York State Department of Health for “Asbestos Handler” and obtain, and keep current, an “Asbestos Handler (Worker)” certificate from the New York State Department of Labor.
- Lead safety and abatement. Yearly refresher training required.
- Hazardous waste safety and abatement
- All applicable OSHA and EPA regulations and updates
- First aid (minimum 6.5 hours)

Blueprint Reading

- Elementary Blueprint Reading

Mathematics

- Basic Arithmetic
- Fundamentals of Trade Math

Industrial and Labor Relations (20 hours)

- History and Background (6 hours, 1st year)
- Current Laws and Practices (14 hours, 2nd year)

Sexual Harassment Prevention Training (minimum 3 hours)

Trade Theory and Science

- Terminology of the Trade
- Materials of the Trade
- Tools and Equipment of the Trade: Operation, Care and Maintenance
- General Construction for the Trade
- Recognition of Hazardous Materials, Areas and Conditions
- Familiarization with HVAC and Pollution Control System Components (if Work Process “I” is selected)
- Commercial Driver’s License with Hazardous Material Endorsement

Other Related Courses as Necessary

A Minimum of 144 Hours of Related Instruction is Required for Each Apprentice for Each Year.
