WHEREAS, the Commissioner of Labor, on February 22, 2016, pursuant to Section 601.9 of Title 12 of the New York Code of Rules and Regulations (NYCRR), duly served upon LeClaire-Fleming Mechanical Contractors, Inc. T/A LeClaire-Fleming Mechanical, Inc. (Sponsor), a Notice of Proposed Deregistration of Apprenticeship Program (Notice) dated February 19, 2016;

WHEREAS, the Notice advised the Sponsor that sufficient cause exists for Formal Deregistration of Sponsor's Plumber and Steamfitter Apprenticeship Training Program (No. 13181) and Sheet Metal Worker Apprenticeship Training Program (No. 15201) (hereinafter collectively referred to as "Programs") and the grounds upon which it proposed that such Programs be Deregistered;

WHEREAS, the Notice further advised the Sponsor that the Programs would be Deregistered unless, within ten (10) calendar days of the receipt of the Notice, the Sponsor files a written request for a hearing with the Commissioner of Labor, New York State Department of

Labor, State Office Building Campus, Building 12, Suite 500, Albany, New York 12240 (12  
NYCRR 601.9(c)(1)(iii);

WHEREAS, on February 24, 2016, the Sponsor received the Notice;

WHEREAS, more than ten (10) calendar days have lapsed since the Sponsor's receipt of  
the Notice; and

WHEREAS, to date the Sponsor has not filed a request for a hearing with the  
Commissioner of Labor;

NOW, it is:

ORDERED based upon the grounds set forth in the Notice and Pursuant to Section  
601.9(c)(1)(iii) of Title 12 of the NYCRR which states in relevant part that a “. .Program will be  
Deregistered unless, within 10 calendar days of the receipt of [the] Notice, the Sponsor files a  
written request for a hearing with the Commissioner,” that the Sponsor's Plumber and  
Steamfitter Apprenticeship Training Program and Sheet Metal Worker Apprenticeship Training  
Program are Deregistered effective March 5, 2016.
