Farm laborers will be required to perform all horticultural tasks related to the production of the vegetable crops, cooking greens, storage crops, and root crops. Workers will be required, but not limited to, the use of hand tools, farm machinery, and irrigation equipment. One month's experience is required in planting, cultivating, fertilizing, the application of pesticides, and harvesting. Knowledge of the quality standards relating to the cleaning, packing, and loading of harvested product will be necessary as well as the ability to bend and lift. Additional activities may include help with farm buildings, and brush removal.

**INTRASTATE AND INTERSTATE CLEARANCE ORDER**

Pursuant to regulations at 20 CFR 655 .122( 0), if, before the expiration date specified in the work contract, the services of the worker are no longer required for reasons beyond the control of the employer due to fire, weather, or other Act of God that makes the fulfillment of the contract impossible, the employer may terminate the work contract. Whether such an event constitutes a contract impossibility will be determined by the CO. In the event of such termination of a contract, the employer must fulfill a three-fourths guarantee for the time that has elapsed from the start of the work contract to the time of its termination, as described in paragraph (i)(1) of this section.
