All of the coaching positions are seasonal in nature. Work will be performed in multiple worksites, NJ work counties include: Hudson, Bergen, Essex, Morris, Passaic, Union, Middlesex, Monmouth, Somerset, Hunterdon, Warren, Ocean, Mercer and Sussex counties. NY Metropolitan work locations include: New York City, Westchester, Nassau, Suffolk and Rockland counties, transportation will be provided from home office in Harrison, NJ to each field location. Candidates should possess an advanced level youth soccer coaching qualification, have at least 2 years of youth soccer coaching experience and have the ability to perform practical demonstrations of soccer skills. No minimum education requirement. RBNY Academy will offer a wage of between \$22.50 to \$28 per hour depending on experience, no overtime. 35 hours per week over 6 days, days and hours vary each week but are typically Monday to Saturday, between approximately 3pm to 9pm, the employer will use a single workweek as its standard for computing wages due, workers will be paid on Friday (bi-weekly) by check or direct debit, the employer will make all deductions from the workers paycheck required by law. If the worker completes 50 percent of the work contract period, the employer will reimburse the worker for transportation and subsistence from the place of recruitment to the place of work. Upon completion of the work contract or where the worker is dismissed earlier, the employer will provide or pay for workers reasonable costs of return transportation and subsistence back home or to the place the worker originally departed to work, except where the worker will not return due to subsequent employment with another employer or where the employer has appropriately reported a workers voluntary abandonment of employment. The amount of transportation payment or reimbursement will be equal to the most economical and reasonable common carrier for the distances involved. Daily subsistence will be provided at a rate of at least \$11.86 p/day during travel to a maximum of \$46 p/day with receipts. Workers will be reimbursed in the first workweek for all visa, visa processing, border crossing and other related fees, including those mandated by the government (except passport fees. The employer will provide workers at no charge all tools, supplies, and equipment required to perform the job, The employer guarantees to offer work for hours equal to at least three-fourths of the workdays in each 12-week period of the total employment period.
