Baker - 1 fulltime, temporary, seasonal (H-2B) job available 4/18/16-12/10/16. Employer: Gunnison Lakeshore Orchards, Inc., 3208 Route 9N & 22, Crown Point, NY 12928. Duties: Worker must properly bake a variety of products, including but not limited to pies/scones/cookies/fritters/donuts and monkey bread. Worker must have knowledge and ability to maintain food inventory and place food orders before any shortages occur. Worker will be responsible for proofing all dough for bread/rolls, making many varieties of fudge and making caramel apples. Must be able to lift/carry up to 50 pounds. Worker must communicate well in English and will be required to interact positively with the public. Workers must have the knowledge to explain all products and the food allergies each product may contain. Additional duties include cleaning the kitchen to NYS Department of Health standards, ordering cleaning supplies for the kitchen and maintaining all water levels with chlorine. Work days: Work hours vary pending seasonal traffic. Work days: Sun-Sat (off Mon); 40 hours/week at \$11.47/hour. OT at \$17.21/hour. Worker will be required to begin work at 4:45am and must stay until all jobs are complete, which may require more than 12 hours per day during peak season. Discretionary raise/bonus. No education required, 1 month experience required. A single workweek will be used to compute wages due. Workers will be paid weekly on Thursday. All deductions from the worker's paycheck required by law will be made. Employer provided shared bunk-housing available for no charge. Employer will provide workers at no charge all tools, supplies, and equipment required to perform the job. The employer guarantees to offer work for hours equal to at least three-fourths of the workdays in each 12-week period of the total employment period. H-2B workers will be reimbursed in the first workweek for all visa, visa processing, border crossing, and other related fees, including those mandated by the government (excluding passport fees). Transportation (including meals and, to the extent necessary, lodging) to the place of employment will be provided, or its cost to workers reimbursed, if the worker completes half the employment period. Return transportation will be provided if the worker completes the employment period or is dismissed early by the employer. Daily subsistence rates are \$12.09/day without receipts or up to \$51/day with receipts.
