Must be able to lift, pull, push, or carry up to 25 pounds or more and walk or stand for long periods of time. Professional appearance, groomed, articulate in English and no visible tattoos or piercings. No education required, 3 months experience in fine dining/country club food & beverage serving. Work Hours: shifts vary, Tues-Sun, 10am-11pm, 35 hours/week at \$13.21/hour. Possible OT at \$19.82/hour. Must be available to work split shifts, nights, weekends, and holidays as needed. A single workweek will be used to compute wages due. Workers will be paid weekly on Friday. All deductions from the worker's paycheck required by law will be made. Employer provided housing (shared room) available for a \$40/week deduction. Employer will provide workers at no charge all tools, supplies, and equipment required to perform the job. H-2B workers will be reimbursed in the first workweek for all visa, visa processing, border crossing, and other related fees, including those mandated by the government (excluding passport fees). Most economical and reasonable cost of transportation (including meals and, to the extent necessary, lodging) to the place of employment will be reimbursed only if the worker completes half the employment period. Return transportation will be provided if the worker completes the employment period or is dismissed early by the employer. Daily subsistence rates are \$12.09/day without receipts or up to \$51/day with receipts.
