Horse Show Groom- 1 fulltime, temporary, peakload (H-2B) job available 11/1/16-7/1/17. Employer: Hidden Brook Farm LP, 471 Hibernia Road, Salt Point, NY 12578. Duties: Attend to overall care of show horses (Hunter/Jumper) including feed, water, maintenance of stalls and tack, bathing, cleaning, brushing, trimming of horses, disinfecting stalls and bedding, inspection and observation of horses' physical condition. Will bandage legs of horses, completely tack them up with bridle, saddle, and correctly fit and adjust aforementioned equipment. Care for 1-5 horses at a time. No education required. 3 months experience required as a horse show groom, or in the performance duties of the job offered. Work Hours: M-F 7am-4pm; 40 hours/week at \$17.50/hour. Workers will be paid weekly on Friday. No transport provided, no OT, no training, no benefits. The employer will use a single workweek as its standard for computing wages due. Employer will make all deductions required by law. Inbound transportation to place of employment provided, or its cost to workers reimbursed, and subsistence costs to worker upon completion of half employment period. The employer will reimburse the worker by check for transportation and subsistence from the place from which the worker has come to work for the employer to the place of employment. Return transportation will be provided if worker completes employment period or is dismissed early by employer. Daily subsistence rates are \$12.09/day, or up to \$51/day, with receipts. The employer will reimburse the H-2B worker in the first workweek for all visa, visa processing, border crossing, and other related fees, including those mandated by the government, incurred by the H-2B worker (but need not include passport expenses or other charges primarily for the benefit of the worker). Employer will provide without charge or deposit charge, all tools, supplies, equipment required to perform assigned duties. Employer guarantees to offer work for hours equal to at least three-fourths of the workdays in each 12-week period of total employment period.
