Duties: Cut, trim, water lawns and flower beds; clean up, weed, plant, spread mulch, rake, blow leaves. Able to lift 50lbs. Daily transportation will be provided to and from worksite (1986 Bennett Road) to the following counties: Ontario, Monroe, Livingston, and Wayne. Pre-employment drug testing required. Pre-hire Criminal Background Check Required. No experience or education required. Employer will train. Work days: Mon-Fri, schedule varies, 7am-5pm, 40 hrs/week, OT varies. Workers will be paid weekly (on Fri) at \$13.81-\$15.65/hr and \$20.72-\$23.48/hr OT, raise at employer's discretion. A single workweek will be used to compute wages due. All deductions from the worker's paycheck required by law will be made. Employer may make payroll deductions at employees request. Employer can facilitate housing arrangements and corresponding payments. Employer does not make any payroll deductions for housing. The employer will provide workers at no charge all tools, supplies and equipment required to perform the job. If the worker completes 50% of the work contract period, employer will reimburse the worker for initial transportation and subsistence costs from the place of recruitment to the place of employment for those traveling from such a distance they are not reasonably able to return to their residence each day. Upon completion of the work contract or where the worker is dismissed earlier, employer will provide or pay for worker's reasonable costs of return transportation and subsistence back home or to the place the worker originally departed to work, except where the worker will not return due to subsequent employment with another employer. The amount of transportation payment or reimbursement will be equal to the most economical and reasonable common carrier for the distances involved. Daily subsistence will be provided at a rate of \$12.09 per day during travel to a maximum of \$51 per day with receipts. H2B workers will be reimbursed in the first workweek for all visa, visa processing, border crossing, and other related fees, including those mandated by the government (excluding passport fees).
