Plan and prepare meals/snacks from scratch under strict food hygiene standards and feed the child. Food allergy experience and epi-pen expertise required. Craft activities for neurological development. Must have driver's license and be able to drive. Must be able to perform physical activities related to the job duties. Work days: Mon-Fri, hours 7:30am-7:30pm, 57.5 hours/week (40 hours at \$15.00-\$21.65/hour and OT at \$22.50-\$32.48/hour). Education & Experience: Requires a minimum of High School Diploma and 1 year of experience. Must have certification in Pediatric First Aid. A single workweek will be used to compute wages due. Worker will be paid weekly on Friday. All deductions from the worker's paycheck required by law will be made. As this is a live-in position, employer-provided housing and utilities are provided at no cost to the worker. 3 meals/day are also provided to the worker at no charge. Employer will provide workers at no charge all tools, supplies, and equipment required to perform the job. Transportation (including meals and, to the extent necessary, lodging) to the place of employment will be provided, or its cost to workers reimbursed, if the worker completes half the employment period. Return transportation will be provided if the worker completes the employment period or is dismissed early by the employer.
